#### **Purpose of This Policy**

New Way Tuition works with children and families to provide tuition and an alternative education provision. We understand that we play a key role in ensuring the safety and wellbeing of children when young people or children are using the internet, social media or mobile devices. New Way Tuition ensures that, as an organisation, we operate in line with our values and within the law in terms of how we use online devices.

	Both parents and children and parents on behalf of their child sign an Acceptable Use Agreement when their time with New Way Tuition commences. Supervised access to an iPad or laptop may be incorporated into sessions, via a secure guest account with high-level filters to ensure only appropriate content can be accessed. If YouTube is used as a learning resource, videos will be watched by Mandy Ward prior to the session in order to assess suitability. During the session, YouTube will be

	Supporting and encouraging the young people using our service to use the internet, social media and mobile phones in a way that keeps them safe and shows respect for others.
	Supporting and encouraging parents and carers to do what they can to keep their children safe online.
	Developing an online safety agreement for use with young people and their parents/carers.
	Developing clear and robust procedures to enable us to respond appropriately to any incidents of inappropriate online behaviour, whether by an adult or a child/young person. Reviewing and updating the security of our information systems regularly Ensuring that user names, logins, email accounts and passwords are used effectively.
	Ensuring personal information about the adults and children who are involved in our organisation is held securely and shared only as appropriate.
	Ensuring that images of children, young people and families are used only after their written permission has been obtained, and only for the purpose for which consent has been given.
	Examining and risk assessing any social media platforms and new technologies before they are used within the organisation.
If Onli	ne Abuse Occurs, New Way Tuition Will Respond to it By:
	Having clear and robust safeguarding procedures in place for responding to abuse (including online abuse).
	Engaging in regular training on dealing with all forms of abuse, including bullying/cyberbullying, emotional abuse, sexting, sexual abuse and sexual exploitation.
	Making sure our response takes the needs of the person experiencing abuse, any bystanders and our organisation as a whole into account.
	Reviewing the plan developed to address online abuse at regular intervals, in order to ensure that any problems have been resolved in the long term.

I also understand that Mandy Ward (New Way Tuition) cannot ultimately be held responsible for the nature and content of materials accessed on the internet. and using mobile technologies.

I understand that my son's / daughter's activity on the systems will be monitored and that Tutors (New Way Tuition will contact me if they have concerns about any possible breaches of the Acceptable Use Agreement.

I will encourage my child to adopt safe use of the internet and digital technologies at home and will inform staff or Mandy Ward (New Way Tuition) if I have concerns over my child's online safety.

The personal data in this form will only be accessed by Mandy Ward.
